

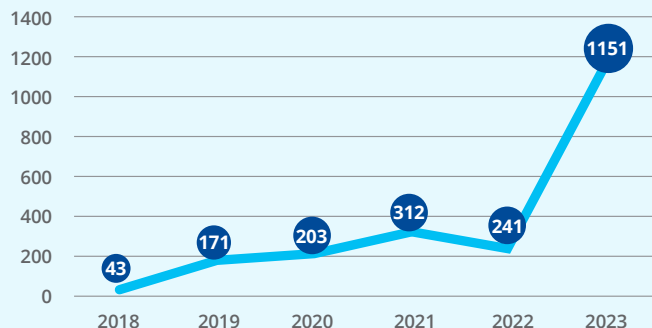
Impacting the Lives of Over 1,000 Students in 2023
